I give, a FULL RELEASE AND WAIVER OF LIABILITY AND ALL CLAIMS that I have, or may have in the future, against Mommy Network, its directors, affiliates, and facilitators, from all liability for any loss damage, injury or expense that I or my dependent may suffer as a result of my participation in any part or parts of the events or
- 5. I understand that the guest speakers/presenters that Mommy Network will recruit are professionals in their field. I release Mommy Network for any mis-information received in the program. I agree to consult a physician for any medical claims made during the course of the program
- 6. I AGREE NOT TO SUE and I further agree TO INDEMNIFY AND SAVE HARMLESS the Releasees from all expenses, fees, liability or damage award or cost of any type whatsoever arising from my and my dependents participation in these events or programs.

I HAVE READ AND UNDERSTOOD THIS WAIVER, RELEASE AND INDEMNITY. I am aware that by signing this agreement I am waiving substantial legal rights (on my behalf and on behalf of my or the child/ward's heirs, executors, administrators and next of kin), including the giving up of my right to sue.

Policies and Releases

Privacy Policy

Any personal information collected by Mommy Network upon registration will not be shared with any third parties. Upon registration you knowingly and voluntarily are providing information to Mommy Network, Inc. Any personal information collect from the participants is used for the administration of the program registered for.

Cancellation Policy

If the entire Mommy and Infant Program is cancelled, you are entitled to a full refund, or have the option to join the next scheduled program.

We will try our best not to cancel an individual session, however our presenters are typically mothers and we need to be accepting of their personal situation. In a case where a class has to be cancelled, you can attend a session with the same topic in a subsequent program within a year of your program. We will however still plan to meet and have activities that day!

Withdrawal Policy

An administration fee of \$35 will be charged (from the amount paid, not including any discounts) and the remaining balance will be refunded to you if you withdraw 14 days before the program start date. If you choose not to / cannot continue in the program, it is your responsibility to contact the Mommy Network Program Director 14 days before the first class of a session.

If you withdraw with less than 14 days notice an administration fee of \$35 will be charged (from the amount paid, not including any discounts) and the remaining balance can be used towards a future Mommy Network program within one calendar year from when your payment was made.

No credit will be issued after the start of the program.

Make-Up Policy

If one class is missed due to illness, vacation, etc., it can generally be made-up if the session is offered again the following program. I understand there is no guarantee a class will be available for make-up. There will be no reimbursement for missed classes or cancellations due to weather. However, in the instance a program facilitator must cancel a session due to illness/emergency, a make-up session will be scheduled.

Medical Release

I hereby give consent for emergency medical care by a duly licensed MD or Doctor of Dentistry. This care may be given under whatever conditions are necessary to preserve the life, limb, or well-being of me or my dependent.

Photography Release

I understand that I or my child may be photographed and/or filmed while participating in the Mommy Network program. The photographs will be the property of Mommy Network, Inc. and no compensation will be given to my child or me if these photographs are used by Mommy Network.
